Use Infinite FX Luna Clear to create special effects, print secret messages or identify a printer's work by printing hidden licensing data. This ink is an excellent under base that reduces fibrillation and brightens some colors. Luna Clear will remain bright after numerous washings and may be printed direct or transferred.

#### **PRINTING TIPS**

- Stir inks before printing
- > Use consistent, high-tensioned screen mesh and sharp edged squeegees for best print results
- For overprint clear print in last position. Best results when printed over "bright" white or fluorescent colors
- For cold peel transfers, use a coated release paper or polyester film. Print Luna Clear using 70 duro squeegee and recommended mesh counts, gel and then backed with colors and followed by adhesive. Gel at 212°F (100°C) for 60 sec. Apply transfer with heat press at 300°F (150°C) for 10-12 sec at medium pressure. Verify process.
